Brief Description of Workshops, Consultations and trainings attended by Members:

- ➤ 30th July 2012: Conducted Advocacy Otraining for CBR partners in Bethany Society.
- > 11-13th October 2012: Attended workshop on "Disability Inclusive Development Training" organized by CDD Bangladesh.
- ➤ 31st August 2012: District Level Workshop on Rural Livelihood & Employment of PWDs organized by Disability Employment Initiative (DEI), Shishu Sarothi in collaboration with Bethany Society in NAWWA Hall, Nongpoh, Ri-Bhoi District. PWD from Nongpoh, Nongsder, Umling, Mawdiangum, Nongkhrah, PahamSyiem, Mawroh attended the programme.
- ➤ 17th Aug, 2012: Advocacy conducted to the BDO of Laskein Block for forming SHG atleast 5 members only for PWDs.
- ➤ 13th October 2012: Distribution of cheques on Social Assistance for PWDs, Widows and infirms; in Shillong Press Club. Melip Sangma was a spoke person on behalf of ACP to the Chief Minister Dr. Mukul Sangma for implementating the scheme.
- > 15th October 2012: Being part of the Review Meeting on PWD ACT. Ms. B.G. Dkhar attended the programme in the office of the Commissioner for PWDs
- ➤ 27-30th October 2012: Conducted a workshop in collaboration with Legal Aid Cell, Bethany Society, on "Capacity building for PWDs" in Municipal hall Baghmara.
- > 14th Nov 2012: published the Poem cassettes into Sign Language and the name of the poem is "Keeping quiet" of class xii. In collaboration with Batesi TV by MS. Ridahun. Khriam from Bethany Society and Mr. Joshua of ST. MARY COLLEGE.

- > 19th November 2012: Collaborated with ICARE on "Consultation Meet on Anti Curruption" in Youth Centre Shillong. The objective is to form a committee amongst the youth in order to be alert on the anti-corruption activities of the government.
- ➤ ACP in collaboration with Bethany Society, NGOs and DPO partners from North East India joined over 1,000 delegates from around the globe attending the first Community Based Rehabilitation (CBR) World Congress. The event was held in Agra, India from 26-28 November 2012, with the aim of promoting CBR as a global strategy to realize the Convention of the Rights of Persons with Disabilities.
- ➤ On 3rd of December 2012, raise Awareness on issue of disability in the state of Meghalaya through media Shillong press on World Disability Day and stressed that Cultural Programme on this day will not bring change, we need action.
- ➤ 15th January 2013: ACP members attended the Citizen's Conference at Martin Luther Christian University on Security of Women and Gender Related Issues. It was organized by ICARE and many delegates from different NGO's were attended
- > 27th January 2013: Collaborated with Social Welfare Department and Commissioner for Women India, on a one day seminar on "Woman Empowerment" in Laitumkhrah, Shillong.
- > 18th 30th February 2013: Attended a workshop on "Gender and Disability" conducted by CBM-SARO in Bangalore.
- ➤ 29-30 Jan 2013: Conducted DPO Taining in Tezpur, Assam for partners EHA Delhi focusing on the formation of DPO.
- > 26th March 2013: Empowerment of Women was organized once again on where they make suggestions on implementation of rights of women.

Some Success Story we would like to Share...

- Bhabiang Shylla was rejected admission in Kiang Nongbah College because she was disabled, the ACP complaint to Commissioner for Person with Disability and created awareness on PWD Act 1995 and 3% reservation in all education and employment Sector to the authorities in the College. Today Bhabiang is admitted and pursuing her graduation.
- Celine Lawai with locomotor Disability initially was very shy, she always tried to exclude herself from social group, never meets people and so on... One day, the President of ACP Mary Khongmawloh met her and explained to her about the ACP and its objectives and activities, she was touched she joined the association and started coming out of her own world. Now she meets people, walk on the public road with wheelchair and pushed by a friend who is visually impaired and is employed. She wants to carry that same spirit and encourage other PWDs who are like her.
- Mr. Bhanu Ghosh person with Speech & Hearing Impairment, who has been assaulted by Assam Rifle Jawans on the 20th of December 2010, as the case is too hard because the victim were discriminate in the court while fighting for his right. ACP met the Special Advocates named Smt. Satrupa Bhattacharjee and Smt. Rebina Subha, from the Legal Right Forum, to follow up and give legal advice. According to them they said that the case should not be stopped but it should be follow up, they also said that on 15th May 2012, they will quietly sit in the court and hear how they speak. If there is discrimination again, they will not say anything but in their group, they will discuss the issues. Bhanu Ghosh has closed the case and he got 2 lakhs compensation for his medical treatment.
